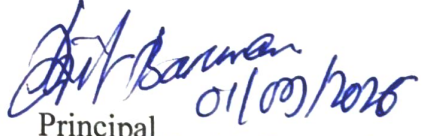

Memorandum

In view of hardship faced by the students due to COVID-19 pandemic situation except admission fees and fees charged by the affiliating Universities, all other fees were suspended during last 3 academic years i.e. 2020-21 to 2022-23.

The COVID-19 pandemic situation has already improved now. In order to collect additional resources for development of the Colleges/ Institutions and to ensure quality education, the General Degree Colleges, Professional Colleges under Higher Education Department are to collect the fees from boys students enrolled as per the following rate from the academic year 2023-2024.

1. Admission fee-Rs.12/- (per semester)
2. Annual fee-Rs. 150/- per year.
3. Cultural and festival fee-Rs. 150/- per year.
4. Internal examination fee-Rs.100/- per semester.
5. Library fee-Rs. 30/- per semester.
6. Identity Card-Rs. 80/-(one time).
7. Laboratory fee-Rs.340/-(one time)
(For Science and Lab based subjects)
8. College Development fee-Rs.100/- per semester.
9. Affiliating University fee (as applicable).

The waiver of all kinds of fees as mentioned above except the fees of the affiliating Universities including registration fees for the girl students enrolled in such Colleges/Institutions will continue to prevail, as notified vide No.F.2(375)-DHE/UDCA (2015/217(26) dated-22nd August, 2022.

This will come into force with immediate effect.
